ACKNOWLEDGMENT OF TERMS & CONDITIONS GOVERNING VOLUNTEER ACTIVITIES

2. Volunteer represents that all information provided in his/her Volunteer Application is complete, true and accurate.
3. Completion of this application and "Terms & Conditions" neither obligates volunteer to perform any services, nor obligates Morgan's Wonderland to utilize volunteer's services. Failure to comply may result in termination of volunteer services.
4. Volunteer represents that he/she has never been convicted of a felony, crime involving dishonesty or fraud, crime of moral turpitude or any sexual or assaultive offense.
5. Volunteer agrees to follow the directions of the MW staff and to abide by all MW policies and procedures.
6. Volunteer agrees to forever discharge and hold harmless Morgan's Wonderland, and its parent organization Sports Outdoor and Recreation, Inc. from any and all actions, claims for relief, suits, liabilities, claims and demands of whatever kind or nature which arise, directly or indirectly, from volunteer's activities with and/or service to MW.
